As at 6.00 p.m. (Singapore time) on 2 January 2024, based on information available to the Offeror, the Offeror has received valid acceptances amounting to 412,431,741 Shares, representing approximately 71.73% of the total number of Shares. This includes acceptances received from persons acting or deemed to be acting in concert with the Offeror in respect of an aggregate of 351,238,510 Shares, representing approximately 61.09% of the total number of Shares².
- (b) Shares held as at the Holding Announcement Date. As at the Holding Announcement Date:
 - (i) the Offeror did not hold any Shares; and
 - (ii) the persons acting or deemed to be acting in concert with the Offeror collectively owned or controlled an aggregate of 421,281,500 Shares, representing approximately 73.27% of the total number of Shares.
