CONDUCT OF MEETING

The Annual General Meeting ("AGM" or "meeting") of the Company was conducted in accordance with the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020.

WELCOME NOTE

On behalf of the Board of Directors, the Chairman, Mr Albert Teo Hock Chuan, welcomed all present to the AGM. The Chairman introduced Mr Foo Ko Hing, Lead Independent Director who was with him, and the other Directors, Mr Lawrence Mok, Mr Chia Kwok Ping, Mr Tan Tiong Cheng and Ms Susan Teo who joined the meeting remotely. The Auditor and Company Secretary also attended the meeting remotely.

QUORUM

Having confirmed with the Secretary that a quorum was present, the Chairman called the meeting to order at 10.30 a.m.

BRIEFING ON THE PROCEEDINGS FOR THE MEETING

The Chairman briefed the meeting:

- Under the alternative meeting arrangement, shareholders were not able to attend the meeting in person to cast
 their votes. Instead, shareholders had appointed him, the Chairman of the meeting, as their proxy to vote on
 their behalf. He would be voting or abstaining from voting according to their specific instructions on each
 resolution. Proxy forms submitted by the 72-hour cut-off time before the meeting had been checked and
 verified by the scrutineer.
- 2. Trusted Services Pte. Ltd. and Samas Management Consultants Pte Ltd had been appointed as the polling agent and the scrutineer respectively for the meeting. The number of votes that he, as proxy, had been directed to cast for and against, and the number of shares in respect of which he had been directed to abstain from voting on each resolution had been verified by the scrutineer.
